- 1. Meeting was called to order at 8:00am.
 - A. Pledge of Allegiance- was recited
 - B. **Verification of Official Meeting Notice**. Notice was given to the West Bend Daily News, Hartford Times Press, Milwaukee Journal Sentinel, and WBKV/WTKM radio station. Notice was posted at Cedar Lake Hills Subdivision, Roskopf's RV Center, the Town Hall, and on the Town website.

 - 3. New Business: Review/Action.
 - A. Approval of the Purchase of New Voting Booths for Town Hall
 - Town Clerk Sandra Rotar stated there was an opportunity to upgrade the Town's voting booths through the Routes to Recovery program grant. Due to the age and construction of the current voting booths welded together and canvas sides Poll Workers are not able to socially distance and disinfect the voting booths as recommended by the Wisconsin Election Commission and other public health agencies for battling the transmission of the COVID-19 virus.
 - Clerk Rotar stated that the Town Board packets included several different models of voting booths based upon the recommendations of fellow municipal Clerks. Ms. Rotar stated she and Paul Melius, the Town's Chief Election Inspector, were recommending the purchase of 12 Starfire model voting booths and 1 Starfire accessible voting both. The cost of each booth is \$150.00 each without a light, \$170.00 each with a light.
